#### Welcome

Al Lalonde welcomed everyone to the Central Okanagan Committee for Safe Schools and shared that at the February meeting a couple presentations were made regarding two homeless initiatives: Journey Home and A Way Home Kelowna.

Ryan Donn shared that since the last meeting the Journey Home Task Force has facilitated Design Labs and Open Houses for the public. A full report regarding the feedback received from surveys, design labs, and open houses will be presented to City Council in the near future. Further updates will be provided at future meetings.

Al Lalonde provided a copy of the article 'Feature Friday: Keeping Central Okanagan schools safe in a new era' that was published in the Kelowna Capital News on March 16, 2018. The article speaks about safety threats posed to students and staff and how the School District has extensive response protocols to assess threats.

Al Lalonde reiterated that all threats are treated seriously and a threat assessment occurs involving an entire team of people. The District is also educating students on their responsibility when using social media.

Deannie Dacosta Zahara shared that the White Hatter Team will be presenting in Kelowna on the subject, internet/social media safety and digital literacy. Presentations are free and are taking place on:

Moyra Baxter thanked Al Lalonde and the RCMP for their involvement and response to the recent Mount Boucherie Secondary School/Kelowna Secondary School threat.

The Committee continued to discuss the importance of messaging when a threat has been made and the critical timing of sending messaging to the media and parents.
