PRESENTATIONS

2025 Summer Projects Update

Presenter: Josh Currie, Assistant Director of Operations

The Assistant Director of Operations provided an overview of the significant efforts taken by the Operations team over the summer months. As in previous years, routine maintenance of facilities, grounds, transportation and custodial is carried out during the summer months. In addition, many complex mechanical upgrades were undertaken, renovations were completed and insurance repairs were initiated. All work required dedication, skill and professionalism. Custodial and Transportation staff also worked diligently to ensure students and staff had a safe, and clean environment to return to in September.

The Assistant Director of Operations provided a PowerPoint Presentation showing photos of various school sites and projects. The Assistant Director of Operations, Secretary-Treasurer/CFO and Superintendent of Schools responded to comments and questions from Committee members regarding:

- Grounds Committee members complimented the grounds crew on school fields looking much better than prior years.
- Geothermal upgrades at École Okanagan Mission Secondary School.
- Status of the renovation to École Dr. Knox Middle School.
- Status of the playground at École Belgo Elementary.
- Insurance claims and deductibles.
- The new middle school announcement on Burtch Road site, and catchment boundaries.
- Ministry of Education and Child Care reversing capital funding decisions in School District No. 62 (Sooke).
- District-wide removal of furniture from schools for fire safety reasons.

Committee members offered thanks to the Operations team for the immense amount of work done over the summer months.

Report to the Finance and Planning Committee - Communication of Audit Results and Audited Financial Statements Fiscal Year 2024/2025

Presenter: Tyler Neels, Doane Grant Thornton (via Teams)

Tyler Neels of Doane Grant Thornton LLP presented the Auditor's Report to the Finance and Planning Committee regarding the audit results of the audited financial statements for the fiscal year June, 30, 2025. As always, the Report highlights:

- Deliverables required,
- Audit risks and results,
- Accounting practices,
- Adjustments and uncorrected misstatements,
- Asset retirement obligations,
- Internal control observations journal entries.

The June 30, 2025 audit of the Central Okanagan Public Schools is substantially completed, and the final audited financial Statements as at June 30, 2025 will be provided, for final approval, at the next Public Board meeting scheduled for September 24, 2025. Once approved, the audited financial statements as at June 30, 2025 will be provided to the Ministry of Education and Child Care by the September 30, 2025 filing deadline.

Mr. Neels and staff responded to queries from the Committee regarding:

- Strengthening internal controls and segregation of duties.
- Different categories to record funding.
- Ministry guidelines and amortization.
- Examples of uncorrected misstatements.

The Committee Chair thanked Mr. Neels and the team from Doane Grant Thornton for their thorough work over the summer.

PUBLIC QUESTION/COMMENT PERIOD

Mr. and Mrs. Holly, long-time residents in Rutland and proud alumni of the Rutland schools, attended the Committee meeting with along with Mr. Wostradowski, to express their disappointment that Rutland Middle School (RMS) continues to remain absent from the government's list of schools slated for replacement or renovation. Their concerns were heightened following the recent announcement of a new middle school to be built on the Burtch Road site. They would like Rutland students to have the same modern facilities as other neighborhoods, and less reliance on portables.

The Trustees acknowledged they shared the same concerns, and recounted the steps they have taken to pursue approval for a renovation to RMS, since school replacements are very rarely approved. Trustees have also advocated by touring government officials through the school.

Trustees affirmed their commitment to continuing to advocate for a renovation. They thanked the group for attending and encouraged them to also reach out to local MLAs regarding this matter.

COMMITTEE MEMBERS' QUERIES/COMMENTS

Trustee Desrosiers acknowledged the recent passing of former Director of Operations Mitch Van Aller, and Trustees reflected on his passion for his work and the care he had for each of the sites in the District.

Audited Financial Statements Fiscal Year 2024/2025

The Assistant Secretary-Treasurer presented the Audited Financial Statements as at June 30, 2025, which included a Statement of Financial Position, Statement of Operations, Statement of Remeasurement Gains and Losses, Statement of Changes in Net Debt, and Statement of Cash Flows and answered queries from the Committee along with Secretary-Treasurer/CFO.

2024/2025 Accumulated Operating Surplus

The Assistant Secretary-Treasurer presented a recap of the 2024/2025 Accumulated Operating Surplus. Board Policy 161 Accumulated Operating Surplus establishes the guidelines and resources on the accumulation and use of operating surplus.

The Assistant Secretary-Treasurer and Secretary-Treasurer/CFO provided clarification to the Committee on the different types of surpluses and acknowledged the concern of Committee members that the District's surplus was still on the low side at 1.6%.
