Advocating for Adequate Funding for Custodial Costs in Childcare Facilities to Prevent Financial Strain on the K-12 Education Sector

Notice of Motion from Trustee Fraser at the December 11, 2025 Public Board Meeting.

Trustee Fraser provided her rationale for bringing this motion forward, in the hope that it goes to the BCSTA AGM. The K-12 education sector currently covers custodial costs for childcare facilities, including cleaning and maintenance services, in addition to its own custodial needs for schools and educational spaces. The responsibility of covering custodial costs for childcare facilities has placed an increasing financial strain on the resources of the K-12 education sector, which already faces significant funding challenges to meet the needs of students and staff;

Superintendent's Emergent Issues

• On January 10, 2025 the Superintendent of Schools/CEO received a letter from Jay Chalke, Ombudsperson, notifying that they are initiating an investigation into the exclusion of K-12 students, and in particular students with diverse needs, from classrooms and schools in British Columbia's public education system. The purpose of the investigation is to determine whether the Ministry of Education and Child Care and school districts are fairly administering and overseeing these exclusions, and whether the rules governing these exclusions are fair. The investigation does not include private or independent schools.

Central Okanagan Public Schools currently has an Administrative Procedure – Student's Adjusted School Schedule Plan (SASSP) and other programs in place.
