Please note that approvals are only for one school year and that you must reapply every year for the subsidy.

For Transportation Services, a separate application must also be completed. Approval for the subsidy does not guarantee approval for school bus transportation.

You can get a Proof of Income Statement from the Canada Revenue Agency (CRA) online or by mail:

### Online

- 1. Register for CRA My Account
- 2. Sign into your CRA My Account online
- 3. Select Tax Returns, then select Proof of Income Statement
- 4. Select the most recent Tax Year from the drop-down list and Search
- 5. Select the Print/Save PDF button

#### By Mail

You can order a copy of the Proof of Income Statement to be mailed to you by calling the automated Canada Revenue Agency (CRA) line at 1-800-267-6999.

You will need to verify your identity when you call. You will need your full name and date of birth, your social insurance number (SIN), your complete address, including postal code and line 150 from your most recent tax assessment. It can take up to 10 days to receive the Proof of Income Statement by mail.
