#### TRUSTEES QUERIES/COMMENTS

#### **Trustee Butler**

Requested an update on the busing situation in Lake Country with regard to courtesy bus riders and safe walkways to schools.

The Secretary-Treasurer responded that a special education bus was reassigned to another needed location in the District, therefore transportation could no longer be provided to courtesy riders on the previous route. The courtesy riders live within the District's walk limits to their school. A number of similar requests for courtesy riders have been received. Once the Transportation Department has analyzed its routes and load capacity at the end of September, there may be areas where courtesy riders can be accommodated.

The Board Chairperson will contact the Chairperson of the District's Safe Schools Committee regarding placing "safe walkways to school" on the committee's next agenda.

#### **Trustee Fraser**

Requested an update on the parking lot modifications that have occurred at Constable Neil Bruce Middle School.

Whereas Section 142 of the *School Act* requires that a School Board submit a capital plan to the Minister of Education; and

Whereas *Municipal Act* Section 937.4 requires that before a school board submits the capital plan required under *School Act* Section 142, it consult with each local government in the school district and, that the school board and local government make all reasonable efforts to reach agreement on the following:

- 1. A projection of the number of eligible development units to be authorized over the 10 year period that has been specified by the Minister of Education;
- 2. The projection of the number of school age children (as defined in the *School Act*) that will be added to the school district as the result of the eligible development units;
- 3. The approximate size and number of school sites required to accommodate the number of school age children projected as a result of the addition of eligible development units;
- 4. The approximate location and value of the school sites; and

Whereas the School District No. 23 (Central Okanagan) Board of Education has consulted with The City of Kelowna, The District of West Kelowna, The District of Lake Country, The Corporation of the District of Peachland, and The Regional District of Central Okanagan;

That: School District No. 23 Bylaw No. 15, School Site Acquisition Charge, enact the following:

- 1. Based on information from local government, the School District No. 23 (Central Okanagan) Board of Education estimates that there will be 16,839 new eligible development units constructed in the school district over the next 10 years;
- 2. These 16,839 development units will be home to an estimated 3,652 school age children who will attend COSD schools;
- 3. Although some of the students from new housing will be accommodated in existing schools, the School Board expects that five new school sites will be required as the result of this growth in the school district. The sites will be located in the following neighbourhoods: Rutland (Rutland Middle replacement), Upper Mission (new elementary and new middle), Winfield (elementary or middle) and Glenmore (secondary).

- 4. According to Ministry of Education standards, the sites will require 19.1 hectares of land. These sites are expected to be purchased over the next few years and, at current land costs, the land will cost approximately \$40,470,000 (with \$29,093,167 attributable to Eligible Development Units).
- 5. Pursuant to Division 10.1 of the *Local Government Act*, the Board establishes the charges applicable to the prescribed categories of eligible development for the school district in accordance with the following formula:

 $SSAC = [(A \times B) / C] \times D \text{ (to a maximum of $1,000)}$ 

A = \$29,093,167 (cost attributable to eligible development units)

B = 35% (Contribution rate set by Provincial regulation)

C = 16,839 (Total Eligible Development Units)

**D** = the factor set by Provincial Regulation for the prescribed categories of eligible development.

The charges applicable to the categories of eligible development as prescribed by BC Reg.17/00 are set out in the table below:

# **Superintendent's Emergent Issues**

# **Updated Enrolment Numbers**

Overall student enrolment will continue to be assessed through the month of September. Currently, the enrolment count is down 178 students. A brief explanation of the varying levels for FTE funding was provided. Once enrolment numbers have been finalized, the District may be in a position to qualify for the provincial grant provided when enrolment decline approaches 1%.
