RECOGNITION/ PRESENTATION/DELEGATIONS

Mikayla Spence, Central Schools Graduate, Student Author

TRUSTEES QUERIES/COMMENTS

Trustee Cacchioni

Advised that Lindsay Gibson, former Kelowna Secondary Teacher, has been involved in the development of a new card game, entitled "Time Shuffle", which introduces students to some of the most historically significant events in Chinese Canadian history, and was developed to help students understand the chronological sequence of events during that time. This resource was developed for the Ministry of International Trade and Minister Responsible for Asia Pacific Strategy and Multiculturalism by Open School BC, the Ministry of Education in partnership with the Royal BC Museum, the Legacy Initiatives Advisory Council, and BC teachers, and is part of Bamboo Shoots: Chinese Canadian Legacies in BC. These are being used as part of the Grade 5 to 10 curriculum.
