# **Celebrating Inclusive Education Month through Learning!**

Inclusive Education staff assisted in organizing the February 16, 2024 CUPE (Canadian Union of Public Employees) Professional Development Day with keynote speaker, Myles Himmelreich. In his presentation, Myles spoke on Fetal Alcohol Spectrum Disorder (FASD) - Myth Busting 101 and FASD Whole Body Research. CUPE and COTA (Central Okanagan Teachers' Association) staff gained valuable knowledge about FASD, the strengths and challenges associated with exposure to alcohol in the womb, and a better understanding of FASD-Informed teaching.

#### INTRODUCTION

#### **MEETING RECESS**

The meeting recessed at 6:31 pm. The meeting reconvened at 6:36 pm.

#### **DECLARATION**

The Board Chair again recognized February 28, 2024 as Pink Shirt and Bullying Awareness Day, and underscored the importance of the annual event. The day originated in 2007 with two courageous students in Nova Scotia taking action to stand up for a younger student.

# PUBLIC QUESTION/COMMENT PERIOD

The COTA President read a statement requesting the Board of Education to consider tabling Item 13.3, the recommendation to delete Policy 505 - Learning Assistance, Regulations 505R - Learning Assistance, Appendix 505A - Learning Assistance (Appendix A) and Appendix 505A - Learning Assistance (Appendix B), regarding Learning Assistance teachers, and the timing of the restructuring of the Inclusive Education Department. The COTA President stated that COTA and Trustees were told that the Policy contained a job description and as such did not belong in board policy, but COTA disagrees with this. The COTA President provided Trustees with a package containing a copy of the letter from COTA's First Vice-President to Trustee Geistlinger, Chair of the Policy Committee, outlining concerns, highlighted excerpts of the Trustee Handbook and Roberts Rules of Order. The main concern is that COTA believes the Inclusive Education Department is set to undergo a major restructuring and the COTA President stated that the timing of the removal of Policy 505 is premature and concerning.

Emily Noonan, a Learning Assistance teacher from Rutland Secondary School asked if Trustees would table Item 13.3 and reconsider, as Learning Assistance teachers were not consulted, and she is worried that the removal of the Policy could have serious implications in the support of students who receive learning assistance.

The Board Chair advised that the removal of Policy 505 is part of a broader project by the Board of Education to review the current Board policies. Item 13.3 is not a discussion on the position of Learning Assistance teachers or their role. This recommendation is to remove the Policy, Regulations and Appendix and instead have the information in the Human Resources posting

process, where all job descriptions and qualifications reside. This Policy removal is for housekeeping purposes only.

Assistant Superintendent Jon Rever provided some history on the 20-year-old Policy 505, and stated that job descriptions, qualifications and roles and responsibilities should exist in the Human Resources Department posting process, and not in Board policy. The timing of this general policy review, and the restructuring of the Inclusive Education Department is purely coincidental. There is no intention to change the role of Learning Assistance teachers.

Nicola Hopfner, Learning Assistance teacher at École George Elliot Secondary School commented that there was still confusion, and that Learning Assistance teachers in the District had not been informed of these changes. Due to the short notice of this policy removal coming to their attention, many could not be at the Public Board Meeting. She stated that her concern is that the deletion of the policy will lend itself to shift the services for current Learning Assistance teachers to case manage more than the Ministry designated students. Ms. Hopfner would like to have this tabled as she considers there to be many unanswered questions.

The Board Chair reiterated that this was part of a broader policy review only. Assistant Superintendent Jon Rever stated that the Appendices in the Policy are redundant, and all specifications and requirements such as the caseload and service delivery of Learning Assistance teachers are guided by the Ministry of Education and Child Care Policy in the Special Education Manual.

## TRUSTEE QUERIES/COMMENTS

Trustee Fraser echoed the sentiments of the Board Chair regarding Pink Shirt Day and the commitment to being kind to one another, and taking a stand against bullying in all its forms.

Trustees and the Assistant Superintendents spoke of the following:

- Attendance/participation in various meetings and events throughout the District, including the annual Joint Board and Central Okanagan Parent Advisory Council meeting, the Webber Road School Community Student Learning Plan Conversation and École Kelowna Secondary Night Owl Theatre presentation of Shakespeare in Love.
- The annual Boys and Girls Club Okanagan Pink Shirt Day Breakfast held on the morning of February 28, 2024 at the Laurel Packinghouse. Trustees, senior staff, and students heard from renowned international speaker Trisha Miltimore who shared insights on building positive relationships, living with less stress and more enjoyment using the tools of kindness, community and gratitude.
- On February 16, 2024 the Central Okanagan Teachers' Association and CUPE Local 3523 held their professional development days. Over 500 CUPE employees participated in 33 sessions facilitated by our District's managers and consultants. The Central Okanagan Teachers' Association (COTA), partnering with the North Okanagan-Shuswap, Oliver, Okanagan Skaha, and Vernon School Districts, hosted a ZONAL conference at Rutland Senior Secondary School with a record-breaking 949 educators in attendance! - assemblies at École Glenrosa Middle School and Constable Neil Bruce Middle School, and a welcome luncheon was held on February 23, 2024 with administration from Haruhigaoka Junior High School, Trustees and Senior Staff.
- Proud for Prom is holding their annual Boutique Day for grade 12 graduates on March 2, 2024 at Quigley Elementary School. Proud for Prom is a 100% volunteer community-based organization whose mission is to empower graduating high school students to be proud of their achievements and celebrate their success through participation at graduation prom night. Proud for Prom ensures that every student has the opportunity to experience their high school prom, regardless of their financial situation.
- Former District Student Council Co-President, Mehak Parihar, who is now a first-year engineering student at UBCO, was the regional recipient of national BGC Canada Youth of the Year. Mehak was awarded this honour for her exceptional leadership, dedication to service and remarkable achievements within her community.
- The BC High School Curling Championships are being held this weekend at the Kelowna Curling Club. The École Kelowna Secondary School team will be looking for their first title on home ice.
- The second annual RCMP/Constable Neil Bruce Middle School charity basketball game will be held on February 29, 2024 at 4:00 pm at Constable Neil Bruce Middle School. West Kelowna Indigenous Police Service unit and RCMP, as well as Westbank First Nation council and community members, will be playing against Constable Neil Bruce Middle grade 8 basketball players.
