The Superintendent advised that a meeting had recently taken place with the four Lake Country school administrators to discuss September 2013 student enrolment. New student registration opens in the Central Okanagan School District on Monday February 4<sup>th</sup>. The first focus group meeting will be held shortly thereafter, once initial registration numbers have been determined. The focus group will include Kindergarten, Primary and Intermediate parent representatives, as well as Lake Country Elementary PAC representatives. The meeting will be held at George Elliot Secondary School (GESS) and representatives of the GESS PAC will be invited to attend. More information will be provided to the Board at a later date.
