Discussion/Action Items

1. School District No. 23 (Central Okanagan) Annual Budget Fiscal Year 2015/2016

The Director of Finance reviewed the highlights of the Annual Budget Fiscal Year 2015/2016 which was developed in accordance with the Ministry's template. The document includes information on the District's known prior year surplus appropriation of \$4,041,831 which is pre-committed into next year's budget. An additional document provided for Committee review contains actual funded student FTE numbers as of September, February and May from 2011/2012 to projected numbers for 2015/2016, as well as staffing FTE for the same timeframe. Board-approved increases to revenue have been included in the preliminary budget, e.g. the increase to the International Education Program enrolment by 25 FTE.

Outcome

The Committee recommended that the Board of Education give first, second and third readings to the School District No. 23 (Central Okanagan) Annual Budget Bylaw for the Fiscal Year 2015/2016 in the amount of \$220,873,139, and that the School District No. 23 (Central Okanagan) Annual Budget Bylaw for the Fiscal Year 2015/2016 in the amount of \$220,873,139, be read a first, second and third time, passed and adopted on the 24th day of June, 2015.

Information Items

1. Administrative Savings Report

The Director of Finance provided a review of the Administrative Savings Report which must be submitted to the Ministry of Education by June 30, 2015. Districts are required to include in the Report the strategies that will be implemented to achieve administrative savings targets over the next two years. Many of the District's previous savings initiatives are acceptable for the savings report and, if the initiatives are being continued in year two, they may be used to achieve year two targets as well. Although the two-year savings requirements have been met, the District will still face a funding reduction of at least \$1 million for 2016/2017. The District's draft Report has been reviewed by Ministry staff who have advised that the savings strategies outlined for year one and year two meet the Ministry's criteria for eligibility.

2. PacificSport Okanagan - Update

This item has been forwarded to the Education and Student Services Committee for discussion at a Fall Committee Meeting.
