# Renewal of Special Program for Positions in the Aboriginal Education Program

*Main* 14P-012

MOVED by Trustee Pendharkar, SECONDED by Trustee Butler,

THAT: The Board of Education approve the application for renewal and expansion of the Special Program with the British Columbia Human Rights Tribunal for positions in the Aboriginal Education Program;

AND THAT: The Board of Education direct staff to include in all advertisements for teaching positions that preference may be given to applicants with Aboriginal ancestry.

The application for renewal and expansion of the Special Program for positions in the Aboriginal Education Program is being requested in order to continue to provide additional cultural role models to work with the District's approximately 2,200 Aboriginal students, in an effort to close the achievement gap between Aboriginal and non-Aboriginal students.

The District has also partnered with the Central Okanagan Teachers' Association regarding the preferential hiring of teachers with Aboriginal ancestry in order to help Aboriginal students make positive connections to their teachers and school.

# <u>Letter From the Minister of Community, Sport and Cultural Development Regarding Input on the Second Phase of Campaign Finance Reform for Local Elections</u>

Trustees discussed the Minister's letter requesting Board input on campaign finance reform for local elections. Pertinent points discussed included:

- In federal and provincial elections, candidate expenses may be written off as a tax expense, however this benefit is not provided to candidates in municipal and trustee elections.
- Campaign expenses are the choice of the individual running for the position and vary greatly depending on the number of candidates running and the number of positions to be filled.
- Campaign expenses for Boards of Education include promoting the awareness of the role of school trustees.

The Board Chair will provide a response to the Minister of Community, Sport and Cultural Development outlining points discussed, by the deadline of January 31, 2014.

# **2014 Online Registration Process**

# World Indigenous Peoples Conference on Education - May 19-24, 2014

- The Central Okanagan School District submitted two proposals for the conference:
  - 1) A Five-Year Agreement has Made the Difference for Students (K-12)
  - 2) Empowering Indigenous Students to Lead at the Local, Provincial, and National Level
- Out of over 400 proposals submitted, both of the District's proposals were accepted and three District representatives will attend the conference as presenters.

# **School Planning Council Process Update**

The District School Planning Council Meeting will follow the same format with 15 minutes for an initial "meet and greet", followed by 60 minutes for collaborative dialogue. The focus question continues to be "How are you meeting the needs of all learners?"
