# Annual Cap Review - International Students at École Kelowna Secondary School

The Superintendent of Schools/CEO advised the Board that the Memorandum provided had a typo. The current International student cap at École Kelowna Secondary School (KSS) is 65 not 60.

Raquel Steen, Assistant Superintendent, presented a map of the District's International students by home country, outlined the number of International students by grade level as well as homestay versus private residence living arrangements. As there are capacity constraints at École KSS, staff recommended that the enrolment cap for International students at École KSS be reduced to 50 Full-Time Equivalent students for the 2022-2023 school year. Staff also

recommended that the International student cap at École KSS continue to be reviewed every October.
