STAFF PRESENTATIONS

Supporting Families with Remote Learning - Device Purchase Program

Presenters:

Jon Rever, Assistant Superintendent Jordan Kleckner, District Principal of Learning Technology John Morrone, Vice-Principal of Learning Technology

Jon Rever, Assistant Superintendent, commended the Learning Technology Department's efforts in supporting remote learning by loaning out over 2,800 devices to students since the BC Government suspended in-class instruction in all provincial schools. Mr. Rever stated that systems and structures need to be put in place to ensure digital equity for all students. As such, there is an option to extend the District's discounted purchase price for laptops and tablets to Central Okanagan families.

Jordan Kleckner, District Principal of Learning Technology, and John Morrone, Vice-Principal of Learning Technology, presented the equity issues in terms of students' access to technology and the need to support families with remote learning. The proposed Device Purchase Program is a cost neutral item for the District and would enable families to purchase devices through the Learning Technology Department at the District's discounted purchase price (for example \$280 for a Lenovo Chromebook 100e or \$630 for a Lenovo Thinkpad 11e including taxes).

Jon Rever, Assistant Superintendent, stated that upon approval by the Board, the Device Purchase Program would be set up and families would be able to pick-up their purchased device before the beginning of the 2020-2021 school year.

The Board Chair thanked Mr. Rever, Mr. Kleckner, and Mr. Morrone for their presentation.

The Secretary-Treasurer/CFO stated over 1,000 bus service applications were received between the original deadline of May 31, 2020 and the extended deadline of June 6, 2020.

- The District completed the first week at Stage 3
- 9,504 students or 42% attended school
- 1,228 students with designations also attended

The Board of Education Trustees and the Superintendent of Schools/CEO reported the following:

- The Board Chairperson thanked everyone for their hard work over the past three months and acknowledged the positive way in which students have been welcomed back to the schools.
- Million Dollar Grant Supports Transformative Education Research at UBCO UBCO is receiving a \$1 million Social Sciences and Humanities Research Council (SSHRC) grant to establish a partnership research initiative for the next five years. The project Co-Curricular-Making: Honoring Indigenous Connections to Land, Culture and the Relational Self is led by Margaret Macintyre Latta, Director of UBC Okanagan's School of Education. Community partners include the Central Okanagan Public Schools, Okanagan Nation Alliance, IndigenEYEZ, Kelowna Art Gallery, Kelowna Museums Society and the Universities of Alberta and Ottawa. The partnership will bring local Elders and Knowledge Keepers together with participating educators and the extended community. By the end of the five-year project, teachers and their students will have gained deeper understandings of Syilx culture with teachings that connect land, culture and understandings of self in the world. Deputy Superintendent, Terry Beaudry, was the District's lead collaborator in working with the UBC Okanagan School of Education.
