#### RECOGNITION/PRESENTATION/DELEGATIONS

## <u>Indigenous-Focused Graduation Requirement – Video</u>

Jasmine Lemon, Acting District Vice-Principal – Indigenous Education, provided an at-a-glance poster with essential information and answers to frequently asked questions about the upcoming Indigenous-Focused Graduation Requirement. Students graduating in the 2023-2024 school year with a BC Dogwood Diploma will need to complete 4 credits of an Indigenous-focused course. A video, recently released by the Ministry of Education and Child Care and the First Nations Education Steering Committee (FNESC), was shared which provided more detailed information. The poster and the video are available for viewing on the District website.

### **Evidence of Learning Continuum (K-12)**

Jordan Kleckner, Director of Instruction – Learning and Innovation, provided an update on the Evidence of Learning Continuum (K-12) project. Prior to 2021, the District had a Central Okanagan Literacy Plan, an existing K-12 Assessment Plan, and Policy 506 – Principles of Assessment Policy. As the understanding of assessment evolved over time, it became important to engage with District Administrators and educators to garner feedback and gather information to improve learning assessment practices. In spring 2022, the District Assessment and Communicating Student Learning Committee reviewed all the evidence gathered and mapped out key themes and trends. Currently, there are various lead teams focusing on the development of the K-12 Evidence of Learning Continuum by exploring potential K-12 numeracy assessment tools, reviewing current K-12 literacy assessments, building an assessment and reporting website, providing Student Reporting Guidelines, and considering professional learning and helpful resources to improve assessment practices.

## Central Okanagan Public Schools Student Reporting Guidelines (K-12)

Jordan Kleckner, Director of Instruction – Learning and Innovation, provided an update on the proposed Central Okanagan Public Schools K-9 Student Reporting Guidelines and the Grade 10-12 Student Reporting Guidelines. Province-wide implementation of the new Ministry Reporting Policy Framework will occur in the 2023-2024 school year.

#### **Outcome:**

The Committee recommended that the Board of Education approve the Central Okanagan Public Schools Student Reporting Guidelines (K-12) (to be fully implemented in the 2023-2024 school year), as attached to the Agenda, and as presented at the January 18, 2023 Education and Student Services Committee Meeting.

# <u>Indigenous-Focused Graduation Requirement Course Proposal: Revised Board/Authority Authorized (BAA) Course – Indigenous Art Studio 12</u>

Jasmine Lemon, Acting District Vice-Principal – Indigenous Education, presented the revised Board/Authority Authorized (BAA) Indigenous Art Studio 12 course. It is intended that the BAA course, Indigenous Art Studio 12, along with the formal letter of support from Westbank First Nation, be submitted to the Ministry of Education and Child Care and the First Nations Education Steering Committee (FNESC) for approval as meeting the new Indigenous-focused

graduation requirement, thereby providing an additional option for graduating students to satisfy the requirements of the BC Dogwood Diploma.

### **Outcome:**

The Committee recommended that the Board of Education review and re-approve the revised Board/Authority Authorized (BAA) Course Proposal – Indigenous Art Studio 12 as meeting the Indigenous-Focused Graduation Requirement, as attached to the Agenda, and as presented at the January 18, 2023 Education and Student Services Committee Meeting.
