Hello Julia!

Oh it's lovely to hear from you. Thanks so much for writing.

I don't have any children at the school, so not aware of the plans sent out. I live up the street with my elderly parents. Dad and I walk by almost every day as Dad has for many years (30+).

I am glad the plans were shared with parents. I imagine people were keen to have the area tidied and I can appreciate that.

Unfortunately, the awareness of the deep impacts of how we landscape isn't broadly known by the public, and the school community (parents, etc) is unlikely aware of the biological considerations and consequences of how landscaping is managed. I wasn't even aware until 5 or 6 years ago. So I'm not trying not to be judgmental but at the same time, it's critical we make changes in how we can support biodiversity and certainly to avoid inadvertently doing more harm.

I have the good fortune of spending a lot of time with and learning from talented Wildlife Biologists and Ecologists. The other important aspect of this is whether the Indigenous People of the School Board / Staff have an informed voice in the plan.

For now, is there a way to at least skip the landscape fabric, leave large soil circles around each tree (2-3m) and just place sod for now? That would help retain the soil in place, avoid the costly destructive use of landscape fabric and also avoid the impact of covering all that soil with rock which becomes really hard to manipulate later. Then a plan for exploring the potential installation of native plants, shrubs and locally sacred plants could be considered? There are many local resources to economically help with next steps after.

If the landscape fabric goes down and the rock is laid on top of it, this will be costly and difficult to reverse.

Would you be so kind to provide the plan, please? That would be a huge help to ensure I'm not making assumptions on the plan.

I've cc'd my trusted colleague and friend, Sara Jordan-McLachlan. Sara is a Biologist who is very knowledgeable of Ecology, native plants, education of children on biodiversity and urban wildlife. I have learned a tremendous amount from Sara, and hope she won't mind answering questions if you have any.

Thanks so much for engaging with me. I look forward to learning more.

I see that non-native trees are now in place. Please confirm the plans for the rest of the area.

I note a sign that says "ReconciliACTION" on the fence at the school. If the plans include anything other than returning the remaining grounds to a native garden, then I have serious concerns.

I have noticed at nearby schools, that landscape fabric and gravel have been laid which are extremely damaging to ecological efforts. Please do NOT do this at Watson Road Elementary.

I noticed there is an Indigenous Student Advocate, Melissa Madden at Watson Road. I've included Melissa here too.
